The Year-end Meeting of the Town of Cambridge duly called and held the 29<sup>th</sup> day of December 2015 at the Town Hall, the following present:

Supervisor Fedler called the meeting to order at 11:30 am and immediately led in the Pledge Allegiance to the Flag.

Auditing of the Bills
