Transfers

Town Attorney

The Supervisor mentioned that she would have to write a letter to the Town Attorney that her services would no longer be needed from the Town of Cambridge. The Town would be appointing a new Lawyer for the year of 2017. She had some concerns about things that were already in progress and would need to be transferred to the new lawyer.

Highway Department

In regards to the Highway Department it was discussed that every 5 years the culverts and bridges were inspected in the town. It was mentioned that given the weather some purchases have been held back on. It was discussed to transfer some of the unexpended balances into a bridge culvert reserve and the Highway Reserve. The Supervisor mentioned that \$5,000 would be set aside on the equipment and \$5,000 for the bridge reserve. Highway Superintendent Jim Buckley mentioned that \$5,000 would not be enough for the bridge that needed to be repaired. The bridge that is to be fixed in the near future is located on Stump Church Rd. towards the direction of County Rt. 60. Due to the high repair cost that the County has quoted Jim Buckley Jr. has requested from the County that a study be done in regards to different methods of repair.
