### **Planning Board Report**

Heather Greenawalt Planning Board Secretary reported that the Town of Cambridge Planning Board met on Thursday, January 7, 2016, 8:00 PM at the Town Hall. There were 5 members present, Secretary and 1 person from the public. Before the Planning Board meeting 4 members and the secretary attended the Planning Board Overview webinar from 6-8 in the Town Clerk's Officer.

Two Planning Board members Danny Thomas and Earl Horton have submitted their letters of resignation. Planning Board Chair Eric Pearson and Supervisor Fedler have discussed the possibility of changing to a 5 person board. Things will have to be researched further as far as the bylaws for the Planning Board.

### **Old Business**

1.) Dominick Giglio was present at the meeting in regards to his parcel #271.-2-27 on Conley Rd. Mr. Giglio is proposing that the parcel #271.-2-27 of 99.71 acres be made into three parcels. The parcel is currently on both sides of Conley road, Mr. Giglio presented a sketch plan the proposed subdivision with lot 1 being 37 acres on the eastside of Conley Road, lot 2 & 3 will be on the westside of Conley Road. The west side of Conley road will be split into 2 lots, lot 2 being 28 acres on the northside with road frontage of 1,008 ft and lot 3 on the south side of the lot with 35 acres with road frontage of 300 ft.

The Planning Board requested that the lot 3 be changed with more of a straight line dividing the tow lots to make more road frontage on lot 3. They requested at least 100 ft. more road frontage. The Preliminary approval was given contingent on the change of the road frontage on lot 3.

Planning Board held the 2016 election of officers Eric Pearson will be the chair and Stuart Ziehm Vice Chair.

The next Planning Board meeting will be on Thursday, February 4, 2016 at 7:30 PM.

## Appointment to the Planning

Supervisor Fedler reported that only one letter of interest was received for the position on the Cambridge Planning Board. Judy Leon submitted a letter of interest to be reappointed to the Planning Board.

## Assessor Report

Supervisor Fedler reported that she would be meeting with Rachael Holbrook the assessor on Wednesday the 13<sup>th</sup> to discuss the random audit of 45 parcels in the Town that was done by the State of New York. She said that they would be going over this information from the state and making a plan. The Supervisor reminded everyone that they must have their exemptions in by March 1<sup>st</sup>. She also reported that this year would be Frank Roots last year serving on the BAR, they would need to look for someone for the year of 2017.

### Code Enforcement

Code Enforcement Officer LaVerne Davis reported that a new house was going in on County Rt. 59 and he was pushing to have done by the March 1<sup>st</sup> deadline for new tax roll.

## Highway Report

Highway Superintendent Jim Buckley Jr. reported that they plowed and sanded roads on January 4<sup>th</sup> due to snow. They replaced idler sprockets, shaft, and bearing for bed chain in Truck #3 and stopped air leaked. Have ordered and received two loads of salt for roads. Highwaymen spent time trimming some brush on Conley Road and cut back on Dailey Lane. The pick-up and plow has been taken to Trius for repair, they have replaced the wiring harness. The culverts were checked to make sure they were open before the rainstorm on the weekend of January 9<sup>th</sup> and 10<sup>th</sup>. The down limbs were cleaned up after the rainstorm. Highway Superintendent reported that he purchased as many parts local that he could for truck #3. The sprockets from Arrowhead were brought to the meeting so that there was no charge for shipping. One of the furnaces quit, the Highway Superintendent checked with Doug's Oil and the new furnace should be installed soon (expected to be installed this Thursday). They are currently running off the other furance and the wood stove until then. They are working on making sure that the MSDS/SDS sheets are up to date. The Highway superintendent has asked Phil Spezio to stop by and make sure everything is up to date – maybe next week. Insulation has been priced for Town Garage roof. Wiley's at \$32.45 per 2 inch thick 4 foot by 8 foot sheet, Highway Superintendent feels this is the best deal. Home Depot and Lowes price is slightly lower, but, not enough to off set the price of getting here. They are not local like Wiley's and Town has an account with them. The Highway Superintendent believes that it will take 140 sheets to do the roof. Wiley's was

agreeable to us getting the insulation as the town uses it (no need to have a large pile stored). The Highway Superintendent is trying to find a man lift, high lift, or scissor lift, that we could be used over time for a reasonable price as opposed to renting one by the day.

Whereas, pursuant to the provisions of Section 284 of the Highway Law, we, the Town Board of Town of Cambridge, agree that moneys levied and collected for repair and improvement of highways, and received from the state for the repair and improvement of highways, shall be expended as follows:

Now, Therefore, Be It Resolved, that the sum of \$85,600 may be expended for general repairs upon 64.04 miles of town highways, including sluices, culverts and bridges having a span of less that five feet and broad walks or the renewals thereof.
