Planning Board Report

Meeting was held on Thursday, July 7, 2022 with 3 members present, secretary and 3 residents.

Old Business

• Public Hearing was held for the Wilmot subdivision of 281 Belle Road tax map #271.-3-13 16.10 acres. Subdivided into 2 lots with road being the boundary. The final acreage of the lot across the road from the house is 9.75 acres. The mylar copy of the survey was submitted. The environmental survey reviewed and Final approval was granted.

• Chad Varney Boundary Line adjustment

Randy Pickering and Chad Varney were both present at the meeting with the survey for 40 Wilderness Way Tax map #254.-1-31, with a boundary line adjustment. This 1/3 of an acre Boundary Line adjustment was basically to give Mr. Pickering his garden and portion of his driveway, which is currently on Chad Varney's lot. The 1/3 of an acre will be merged with Mr. Pickering's parcel 254.-1-35 located at 38 Wilderness Way. Final approval was granted.

Highway Report

- Highway Superintendent Jim Buckley Jr. reported that they have had both mowers out on roadsides.
- They have mowed the cemeteries for July 4th.
- They have also done ditching and have replaced some culverts.
- The gravel screen has been loaned to Salem Highway.
- People have been dumping Garbage along the roadside.
- Greg Woodcock Councilman from the Town of White Creek has approached Town Board members and asked of the Highway Superintendent to do certain things. He is requesting that the Town of Cambridge paint lines on Turnpike. He has no right to make these requests. The Highway Superintendent has been through this before with him and put him in his place.

Communications

Letter was received from North Eastern Expansion Development, Corp. in regards to the development plan for the old Mary McClellan Hospital, located at 1 Myrtle Ave. They are requesting a copy of any Feasibility study and results that were initiated prior to the construction of the water tower. This portion of the property is located in the Village and any studies or paperwork would reside with the Village of Cambridge. Question was asked by Councilman Bailey if there were any more complaints about the property on Conley Rd. This is the Wedding Venue where they were having the parties and causing issue with the neighbors. There had been no complaints as of yet this year.
