## **Communications**

Report from the Town Board Meeting April 12<sup>th</sup>. Eric Pearson Planning Board Chair and Scott Clark the Vice Chair attended the April 12<sup>th</sup> meeting and reported to the Town Board on the Virtual Meeting. They also reported what they felt would be the best step for the Town to take towards managing large solar projects/arrays. The Supervisor requested that Scott Clark put in writing and present to the Planning Board what his recommendations are for a Site Plan for Large Solar projects/arrays.

Scott's suggestions can be reviewed in his email to the secretary to the Planning Board, and some of them are listed in this list:

The Planning Board Suggestions:

- 1. Bond for Decommissioning Biggest concern
- 2. Glare restriction

It was suggested by Eric Pearson that this Law be strictly for Solar - Stand alone issue.

- 3. Anything outside General Homeowners for Solar would trigger the seeker (anything over the net metering size of the trigger)
- 4. Pick up lawyer fees and need professional consultant

It was suggested to put in the Law whatever we need to review the project.
