Public Hearing

At 7:35 PM, Chairman Pearson opened the public hearing regarding the one lot minor subdivision application submitted by Jacqualyne Hersey. Mrs. Hersey owns 18.48 acres at 418 County Route 60 identified by tax map #262.-1-10. She is proposing to subdivide out an 8.225 acre lot to convey to adjacent property owner Randy Hamilton. Included in the subdivision is a mapped out 50 ft. right -of-way (driveway) granting ingress and egress privileges to Mr. Hamilton and another property owner, Brian Taylor. The right-of-way is included in the subdivision and ownership of it will be transferred to Randy Hamilton. Brian Taylor will have continued use of the driveway. A note on the subdivision map confirms it. Mr. Taylor acknowledged he has been fully apprised of the change and is ok with it. Mrs. Hersey will retain the remaining 10.225 acres south of the right-of-way which contains her home. The subdivision map was displayed and carefully reviewed by the board. Since there were no comments from the public, the hearing closed at 7:40 PM.
