

Assessors must sit with the tentative assessment roll for at least 4 hours on each of 4 days. A total of 2 hours must be after 6 p.m.

One sitting day must be a Saturday.

At least two sitting days must be at least ten days after the date the tentative assessment roll is filed.

The Board of Assessment Review must meet for at least 4 hours with two of those hours after 6 p.m.

Return completed form to Real Property Tax Service as soon as possible.
