It was mentioned that still looking for someone to clean the Town Hall. The quote that was received was double the budget amount for cleaning. It was decided to continue looking. Councilman Carrino said that Keanna was still interested in the position and he would give her a call.

Town Justice Position

Supervisor Fedler mentioned that the State stepped in and appointed Judge Flint to the Town of Cambridge Justice position until the end of April. It was mentioned that the Town could decide to appoint someone to the Justice position at the end of April or they could just wait until the election occurred. The Town would have to advertise due to the appointment policy and then check in and make sure that the training was offered for the appointed Justice. Councilman Bailey mentioned that he had concerns: if there are many running for the position in the fall and they have an appointed Judge could there be issues? Should the Town of Cambridge be considering consolidation? The Supervisor mentioned that the Town Board should review the email that Judge Flint sent the Town Board on Consolidation. Suggested that look at both sides when it comes to consolidation.

The Supervisor summarized her understanding of what the Town Board was comfortable with: The Town Board is not interested in appointing at this time and will review the paperwork that Judge Flint has sent out on consolidation of the Court. They will wait till Election in the fall for the election of a new Judge.

Thank you note received from Cambridge Food pantry for money received and for putting line item in the budget.

<u>IDA</u>

The new deadline for the IDA has moved to March 1st. Request that 3 Washington county Representatives sat in the meeting. Solar was hot topic. The IDA will be going over input and bringing a new policy forward. Supervisor Fedler mentioned that multiple Towns not happy with the IDA.

Planning Board Report

- Planning Board meeting held February 2, 2023 with 4 members present, secretary, 2 people from the public.
- Sketch Plan presented by Jake Trinkle for his father's property located at 291 Dickensen Road, tax map #280.-1-9. The proposed minor subdivision is to subdivide the house on the corner of Belle and Dickensen Road, out from the farm and the property. The total acreage of the parcel is 214.5 acres. The house will be subdivided out with approximately 1.5 acres. The only concerns that the Planning Board had we the correct boundary lines from the barn which would be 50 ft. and that the well and septic would be with the distance needed. Planning Board gave permission to proceed with the survey.
- Planning Board members asked about the Solar Moratorium and where the Board was with the process of creating a Local Law. Filled them in and forwarded on the sample law.

Highway Report

- They have firmed up the worst of the soft spots with econo-gravel, with mixed results.

The Town Board gave Jim Buckley the Highway Superintendent permission to order the Truck Body with the understanding that the price (\$53,000) could possibly go up due to a surcharge.

Short discussion about purchasing another plow truck due to the increases and the long waiting list.

Town Board

Councilman McIntosh brought up the topic of Solar law and said that he thought that could possibly omit information on tier 1 or tier II. This was the section on houses/yards, limited 110% usage, not commercial or solar farms. No regulations on non-commercial stuff.

This would be discussed further when have more time, meeting was running late.

Assessor Contract

Councilman McIntosh motioned, seconded by Councilman Bailey to approve the new updated contract with the Town of Cambridge and Washington County Real Property contracting an Assessor from January 1, 2023 to December 31, 2023.

The County has decided that maybe they are not getting enough money for contracting services for the Assessor so they are considering changing their prices. The new pricing should come out late summer, so will know in time for the budget time.

Privilege of the Floor

Susan Herrington presented to the Town Board Resolution for an Audit of the New York State 2022 General Election. Copies were handed out to the Town Board Members and Susan Herrington asked that the Town Board possibly read through and consider. She is asking of the Town Board for support of a NYS wide audit. She has requested to be put on the agenda for the next meeting.
